I, the undersigned, _____(full names), hereby confirm that I am 18 years of age or older and understand the contents of this indemnity. I understand and appreciate the inherent risks and dangers of the location of the prison, being outside of a built up urban area in an abandoned space.

I also take note of the fact that there are no toilets / showers / heating / beds and bedding on the premises. I understand that the activities that I will be engaging in may be inherently dangerous and may create certain risks to persons that can result in physical injury and/or mental distress.

I acknowledge and undertake that I have no claim against Mistress April and her personnel on account of death or personal injury or the loss or damage to personal belongings arising from any cause whatsoever and indemnify and hold Mistress April and her personnel harmless against any such claim, demand or liability. I confirm that I have read, understand and accept the rules of my consensual prison stay and undertake to follow them. Without limiting the generality of the foregoing, I hereby confirm that I am responsible for my own safety with regards to the activities that I have consented to for Mistress April to perform on me and I do so of my own free will. I confirm that I acknowledge that the activities I am participating in are a role play/ fetish fantasy.

I confirm that I have entered the prison of my own free will and will be willfully engaged in the consented activity as detailed in my application form. I also hereby state that I am aware there is a safe word "Red" that I can use at any time, to end all activities and be released from prison with no refund.

I HEREBY GIVE MY PERMISSION TO THE RESPONSIBLE PERSONS TO, IF NECESSARY, TAKE ME TO A DOCTOR OR HOSPITAL AND AGREE TO EMERGENCY TREATMENT.
